Waiver, Release, and Assumption of Risk

In consideration of the acceptance of my application for entry in SuperTour 2003, I, the undersigned, hereby waive, release, and discharge any and all claims for damages for death, personal injury or property damage which I may have, or hereafter accrue to me, as a result of my participation in SuperTour 2003. This release is intended to discharge in advance the promoters, organizers, leaders, assistants, bus drivers, cooks, the promoting organization and any officers, and any involved municipalities or other public entities from and against any and all liability arising out of or connected in any way with my participation in said event, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I further understand that serious accidents may occasionally occur during a bicycle event such as SuperTour, and that participants in such bicycling events occasionally sustain serious or mortal personal injuries, and/or property damage, as a consequence thereof. Knowing the risks of participating in SuperTour 2003, nevertheless, I hereby agree to assume those risks and to release and hold harmless all persons and entities liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns.

I acknowledge and agree that this tour is organized and promoted in and under the laws of the State of California. I am signing this waiver and release form with the full knowledge of California Civil Code Section 1542, which reads: "A general release does not extend to claims which the creator does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor". The provisions of this statute are hereby waived.
